**Sub:- Essentiality Certificate for permission to start P.G. Courses in the departments of Microbiology, Skin & VD, Obst. & Gynae, Surgery and Radiology in Sri Krishna Medical College, Muzaffarpur - reg.**

Sir,

It is proposed to apply for permission of starting P.G. Courses in the aforementioned departments of Sri Krishna Medical College, Muzaffarpur. This college is a Govt. College and the Principal has been advised to make an application to the MCI for the same. The essentiality certificate for the same is furnished as follows:-

- (1) No. of Institutions already existing in the State:- 12 (9 Govt. & 3 Private Medical Colleges)
- (2) No. of seats available or No. of doctors being produced annually:- 1300 (950+350)
- (3) No of doctors registered with the State Medical Council : Not available at Present
- (4) No. of doctors in Government Services : Approx 4500
- (5) No. of Government posts vacant and those in rural/difficult areas : Approx 10000
- (6) No. of doctors registered with Employed Exchange : Not available at present
- (7) Doctor population ratio in the State : 1:22000 (Approx)
- (8) How the establishment of the college would resolve the problem of deficiencies of qualified medical personnel in the State and improve the availability of such medical manpower in the State :- It will reduce the doctor : patient ratio in the State specially the specialist doctors & medical teacher.
- (9) The restrictions imposed by the State Government, if any, on students who are not domiciled in the State from obtaining admissions in the State, be specified. : N.A.
- (10) Full justification for opening of the proposed college:- The Doctor Population Ratio as envisaged by Planning Commission (Niti Ayog) will be achieved which in turn will attain the Health Indices under NRHM and also make available the required teachers for future.
- (11) Doctor-patient ratio proposed to be achieved.: 1:3500

It is further certified that in the case adequate infrastructure for the Medical College as per MCI norms are not created and fresh admissions are stopped by the Central Govt., the State Govt. shall take over the responsibility of the students already admitted in the college with the permission of the Central Government.
